

## Personal data request

According to the data protection regulation, the data subject has certain rights to their personal data. These include, i.a., the right to be informed of the processing of their personal data, obtain a copy of the processed personal data, remove the data, restrict the processing of the data, transfer the data from one system to another and oppose to the processing of the data.

When you wish to review, remove or transfer your personal data, obtain a copy of your processed personal data or have other questions related to your data, please fill in, print and sign this form and send it to the address provided hereinafter.

The data subject cannot exercise all their rights in all situations. The situation is affected by, for example, the reason for processing the personal data. We process all personal data requests and reply without undue delay; in any case, within a month of receiving the request. If your request is more complicated in nature or we have received several requests at the same time, we may postpone the reply by no more than two months. In such a case, we will notify you of the postponed reply.

**Proof of your identity**

It is important that the requestor has been identified as the data subject before the request is processed and completed. This is done to ensure that the information of data subjects is processed in accordance with their wishes and to ensure that another person will not gain access to the other data subject's personal data or have the data removed.

Be prepared to prove your identity, if necessary. If we ask you to prove your identity, we will need a copy of your passport, driver's licence or identity card, or you can come and prove your identity at our office. In this case, we will contact you separately. We cannot process your request if we are unable to identify you.
